JANUARY HIKES

Athens Regional Park Trail Hike - January 22, Sunday afternoon

Hike leader: Jane Bohannon. Rating: easy. Length: 3.1 miles.

Plan to meet at the trailhead at 2:00 p.m. The mountain bike/hiking parking lot is the first turn to the left after entering the park. This trail has its ups and downs and scenic views in woodland, open field, and paved area around the lake. It is a hike around the perimeter of the park and along North Mouse Creek.

Directions to the park from Cleveland: Take I-75 north to the first Athens exit, then turn right onto Highway 30 toward Athens. The park is approximately 1 mile on the right.

Directions to the park from Etowah: Take Highway 30 through Athens all the way to the park. The park is approximately 1 mile on the left after the Highway 11 (Congress Parkway)/Highway 30 (Decatur Pike) intersection.

Driving directions: The Family Resource Building is located at 3680 Michigan Avenue Road in

Cleveland. At the Paul Huff Parkway/Highway 11 (North Lee Highway) intersection take Stuart Road east passing Golden Corral and Hobby Lobby (Paul Huff Parkway will turn into Stuart Road as you continue east through the intersection). Follow Stuart Road until you come to the intersection of Stuart Road & Michigan Avenue Road, right past the YMCA on your left. Turn right onto Michigan Avenue Road. The Family Resource Building is approximately 0.1 mile on the left. There is a sign in front of the large brick building and a large parking lot in front.

Hike Leader Responsibilities Regarding Hike Pictures

Since this is the start of the new year, the Club board has been reviewing and updating the Club policy related to pictures taken on Club hikes. We would like to inform all potential hike leaders of their responsibilities related to pictures that are taken on Club hikes:

Hike Sign In Sheet: We remind all hike leaders to have all participants, members and non-members alike, to sign and fill out the blocks on the Hike Sign-In Sheet, which is available for download and printing on the Cherokee Hiking Club website under the "Forms" drop-down menu. Photo Release: On the form, there is a column at the far right (the column heading is "*Permission to Use Photos*") to be initialed by participants to provide permission for photos to be used by the Cherokee Hiking Club on the CHC website, the CHC Facebook page, and the CHC newsletter, as *well as for publication in any other way*, such as a newspaper article. Be sure all participants initial this block. If a participant refuses to initial this block, then any picture with this person in it cannot be placed on the CHC website, CHC Facebook page, newsletter or other CHC-supported publication such as a newspaper article.

It is requested that any pictures of hike participants posted on the Club's Facebook page (or any other Facebook page or page of any other social media such as Picasa, etc.) are not **"tagged"** with the name of the hike participant or any of his/her guests. (**Tagging** is employed by social media sites such as Facebook, and it allows anyone posting that picture to place a label on or near a specific person's image in order to identify the person(s) in the photograph. Note that this CAN include images of any children.) We are discouraging tagging out of courtesy for many of the Club members who are either not familiar with Facebook or not comfortable with sharing their private lives and loved ones in a very public forum such as Facebook or other social media sites.

All the above being said, it must be pointed out that the **Cherokee Hiking Club cannot control what individuals do on their own Facebook pages**. If a hike participant shows a picture of another hike participant or even tags a picture of that participant on their own personal Facebook page when that participant has *not* initialed the *Permission to Use Photos* column noted above on the Hike Sign-In Sheet, then that issue is between the participant and the person whose picture was so used, and does not involve the Cherokee Hiking Club.

Right to Privacy: Please remember that the above is out of courtesy for Club members' privacy. In fact, anyone can take a picture of another person in a public area such as on a club hike, and use that picture if they so wish. From a legal perspective, **privacy is not guaranteed to anyone when out in the public eye.** Such privacy is only granted when that person is in a private location, such as in a person's own home.

Hike Pictures Appearing in the Newsletter and Club Website: If all participants have agreed to have their pictures posted publicly, and have so initialed the *Permission to Use Photos* column on the Hike Sign-In Sheet, it is the **hike leader's responsibility** to get the pictures of that hike to the newsletter editor and club webmaster, in electronic form by email. The hike leader can choose which pictures he/she sends to the newsletter editor and webmaster; or he/she can choose to send none at all. Pictures are posted to the newsletter as an additional feature to make a hike write-up more interesting, but are not required.

Picture attachments can sometimes get quite large, so please only send to the newsletter editor/webmaster about 3 or 4 pictures maximum in one email. Links to pictures posted on a third party website (such as Facebook or wherever) will not be employed to retrieve pictures for posting in the newsletter; however, pictures already posted to the Club website may be, if a link or hike title is provided. Sending large size pictures via email is acceptable, but will be sized down and/or cropped by the newsletter editor before publication. It is up to the newsletter editor and/or club webmaster as to which pictures are chosen for publication. Since the newsletter is sent out via email, only 3 or 4 pictures at maximum are published in one month's newsletter. Because the newsletter is sent out as an email attachment, it is important to consider that some people's internet connections cannot handle a wide bandwidth, which images require.

Recent Hike & Event Reports

Foster Falls Hike – December 3, Saturday

Five club members drove over to Marion County on a nice December day to enjoy the beautiful Foster Falls area - part of South Cumberland State Park. We started the hike by enjoying a view of the Falls from the viewing platform located just a few hundred feet from the parking lot, before descending steeply to the bottom of the Falls and the nice, deep pool at the base of the gorge. The week's heavy rains had filled the creek nicely, so the water volumes were spectacular. We then hiked along the base of the rock bluffs as the first rock climbers of the day were beginning to ready for their ascent up the rock faces. We ascended to the top of the gorge by utilizing the second Climber's access trail (with the use of sturdy wooden stairs) and joined the Fiery Gizzard Trail.

Once on top, we hiked along the top of the gorge for about 1.5 miles and enjoyed nice overlooks of the gorge and three smaller waterfalls plunging off the face of the cliffs. We then descended steeply down into Laurel Branch Gorge and ate lunch beside a clear, rushing stream that reminded me of the Great Smoky Mountains National Park.

After lunch we climbed out of the gorge on down the Fiery Gizzard Trail. Upon our final ascent out of the gorge, "Trailblazer" Rick Harris and his trusty, GPS unit then led us around the gorge on a "bushwhack" that allowed us to explore new territory while avoiding a backtrack into Laurel Branch Gorge. We regained the trail exactly where the GPS indicated we would, and then hiked back on the Fiery Gizzard Trail to the parking lot. Along the way we experienced views of Foster Falls from the opposite side of the gorge, a great small waterfall at a 90 degree angle to the main stream, and the beautiful rapids of the creek above the Falls.

If a guest hiker should take photos, then the guest would be taking on their own liability for their actions. Hike leaders are responsible for getting a copy of the Liability Waiver to the club secretary for filing.

<u>Hikes completed:</u> Since the last meeting the following hikes have been completed: Fort Loudon State Park Trail Hike led by Bob and Effaleda Lee, and the Foster Falls hike led by Randy Morris. The Linda Davis Memorial hike was cancelled.
